Directions For Use:

Important: Always test first on an inconspicuous area. Use painters' tape and plastic drop cloths to protect any surfaces you do not intend to strip.

Note: Textured ceilings installed as late as the mid-80's may contain asbestos and/or lead and should be tested prior to removal. If test is positive, you must follow local, state and federal regulations on the containment, removal and disposal of these hazardous materials. You should wear a protective goggles and NIOSH approved respirator to control exposure. Carefully clean up with a wet mop or HEPA vacuum.

Directions: Apply liberally with a standard pump sprayer, foaming pump sprayer or Foam-It to the surface being stripped. Allow to dwell on surface for a minimum of 15 minutes, depending on the thickness of the paint and coating to be removed it could take longer. Using a scraper blade, test a small area, coating should remove easily from the surface. If not, allow more time to penetrate before testing again.

Once the coating is sufficiently softened, use a scraper blade to remove, taking care not to damage the underlying surface.

You should wear a Face mask and eye protection during this work. When scraping it is good idea to keep the texture wet to prevent dust.

After removal is complete dispose of material removed according to local, state and federal regulation. Prior to painting, wipe down the surface and patch any irregularities.

STORAGE: STORE IN ORIGINAL CONTAINER IN A DRY, COOL AND WELL VENTILATED AREA AWAY FROM STRONG OXIDIZING AGENTS. KEEP CONTAINER TIGHTLY CLOSED WHEN NOT IN USE.
