## Shake Well Before Use

- 1. New teak should be allowed to weather for 2 weeks and rinsed with water prior to treatment.
- 2. Grey teak or teak treated with teak oil must be cleaned Teak Cleaner prior to treatment.
- 3. If cleaned wood feels rough, sand lightly prior to use of Teak Sealer. Make sure the surface is completely dry and free of dust.
- **4.** Shake will prior to use to assure consistent coverage and protection of the surface being treated.
- **5.** Always test in a small inconspicuous area to assure the finish meets your expectations.
